# JCBA honors Herb Newman on June 26

There's a good reason why the JCBA's event to honor Herb Newman on June 26 is taking place at the Shaw JCC—Herb wouldn't have it any other way. For someone whose life has always revolved around "The Center," it made perfect sense.

"It was the 'center' of his life," echoes Herb's wife Dianne Newman. "He participated in sports, day camp, afterschool learning, and social activities. That's where we met. It was his home away from home. He was at [the JCC on] Balch Street four or five nights a week."

Herb's immersion in the Jewish community started with his parents and grandparents, who were very active in the Workmen's Circle. He grew up in a Yiddishist home, only learning enough Hebrew to make his bar mitzvah. Even so, "he gave a bar mitzvah speech in Yiddish at Balch street," Dianne says. "The rabbi was very angry and announced afterward, 'Herbert speaks English too!' "

Herb followed his father into the family insurance business, but started law school at nights in 1961 soon after marrying Dianne. He graduated from University of Akron School of Law in 1965.

Appointed director of the Akron Metropolitan Housing Authority (AMHA) in 1972, Herb pioneered several projects during his five-year tenure there that are now used nationwide. As part of Ronald Reagan's transition team, Herb wrote many laws for subsidized housing that are still used today.

# Herb Newman continued from page one

Through his work, Herb has built low-income housing throughout Summit County. "He established the first congregant living center in the United States," says Dianne. "It was an old motel across from O'Neill's in downtown Akron. There were separate rooms but communal dining for the senior residents." Under his leadership, AMHA instituted many social welfare initiatives that complemented the agency's mission to encourage responsibility and pride in the home.

"Herb is a brilliant business man," remarks David Koch, CEO of the Jewish Community Board of Akron. "The outcomes of his creativity and conscientiousness have greatly benefited Akron—and beyond, really. We are lucky that our community has his expertise and also his longtime dedication to Jewish Akron."

It was Herb who secured the subsidy for Center Towers, the apartment building that rests next to the 750 White Pond campus. He and Stan Bober "wrote in an option for the 'Akron Jewish community' to buy Center Towers after 20 years, which it did," notes Dianne. He has made sure the community has really benefited from owning that building."

Herb has always looked out for Akron's Jewish community,

often quietly doing so in the background. He served on the board of the Center during the time the White Pond campus was being built. Through the JCC, Herb was appointed chair of the Hebrew High committee in its formative years. In his own, unique way he brought the Jewish community partners together, establishing a service for all teens regardless of affiliation. "He told each of the rabbis, 'You might as well agree, because the others won't agree," says Dianne.

Herb's tough exterior is really just a shell for the softness underneath, say the ones that know him best. "He plays the devil's advocate and likes everyone to think he's a bad guy, but he's really a good guy underneath," explains longtime friend Myrna Berzon. When Herb first met Elan Krueger, the husband of Newman's late daughter Karin, Herb called him an unprintable name. Elan was taken aback but Karin reassured him, saying, "that means he likes you!"

Son Ed Newman shares that Herb has the best sense of humor in the family, while daughter Paula Newman Pollachek says her dad is the "Jewish mother of the family." "He's the one who keeps the family together," says daughter Nancy Zacky.

Herb's family-mindedness is not surprising, given his loyalty and commitment to the community. "He cares about Akron and the Jewish community and always has," says Dianne. "He was born and bred here and will never move away. And I feel the same way."

# Dianne Newman honored with Athena Award



Dianne R. Newman, co-founder of and lawyer with the firm Shifrin Newman Smith, Inc. was awarded the *Inside Business* ATHENA AWARD as a Social Artist, shaping and supporting non-profits.

Newman is president of Akron Art Museum's Board of Trustees, having served on the board for more than a decade. She has helped raise millions for Akron non-profits, notably co-chairing a successful \$2 million campaign for the Women's Endowment Fund of the Akron Community Foundation.

She tells *Inside Business* magazine: "I have my hierarchy of philanthropy. First, I give to Jewish organizations because there are fewer Jews. Second, I give to women's and arts organizations because fewer people give to those organizations. Third is education and fourth is medical."

# Oppenheimer, Slesnick spearhead mobile sushi truck

Sushi on the Roll restaurant owner Ken Oppenheimer and his food truck partner Margaret Slesnick announce the debut of its new mobile sushi bar, a full service gourmet mobile food truck hitting the streets of Northeast Ohio. The food truck will be parked at Blossom Music Center this summer and will be seen at various venues around the area including Walnut Wednesdays and The Chomp/Pour in Midtown, Cleveland.

The menu features traditional sushi rolls, as well as salads and specialty burritos, an unorthodox combination of sushi ingredients wrapped inside a wheat tortilla. "This is merely an extension of the restaurant, our kitchen on wheels," says Oppenheimer.

Mobile Sushi Bar is the first mobile sushi truck licensed in the Midwest. Customers can order online in advance by a specified time for an event and it



will be ready for pick up to avoid long lines.

How does a Jewish guy get involved with sushi? Oppenheimer was unable to get sushi delivered for lunch or special events at his former place of employment. After much research, he determined that a sushi business that delivers fresh sushi, provides wholesale products and offers catering would be a new business model not previously done in Northeast Ohio. 

# Tax law changes, effects on charitable giving

Rabbi Hillel explained Judaism while standing on one foot. I am no Rabbi Hillel – I took seven paragraphs to summarize recent changes in tax law that impact charitable giving:

## **Charitable IRA Rollover**

The "Charitable IRA Rollover," revived through the end of 2013, allows taxpayers age 70-1/2 or older to make distributions from their IRA directly to qualified public charities in an amount up to \$100,000.

# **Individual Income Tax Rates**

ATRA (The American Taxpayer Relief Act) permanently retains the 10%, 15%, 25%, 28%, and 33% income tax brackets. The 35% tax bracket ends at \$400,000 for single filers. Above this threshold, there is a new 39.6% tax bracket. Thresholds for the new 39.6% bracket for 2013 will be:

- Married Filing Jointly: \$450,000 of taxable income,
- Head of Household: \$425,000 of taxable income,
- Single: \$400,000 of taxable income

Remember, the higher the rate, the higher the tax incentive to give.

# **Long-Term Capital Gains Tax Rates**

ATRA permanently retains the 0% and 15% tax rates on qualified dividends and long-term capital gains and adds a new 20% tax rate that would apply to taxpayers who fall within the new 39.6% tax bracket. Which capital gains tax rate will apply depends on what tax bracket a person is in. The new capital gains tax rates for 2013 and future years will be:

- 0% applies to capital gains income if a person is in the 10% and 15% tax brackets
- 15% applies to capital gains income if a person is in the 25%, 28%, 33%, or 35% tax brackets and
- 20% applies to capital gain income if a person is in the 39.6% tax bracket.

Again, the higher the rate, the higher the tax incentive to give long term appreciated assets.

## **Alternative Minimum Tax**

ATRA provides the following AMT exemption amounts for 2012, and provides that these amounts will be indexed for inflation annually:

- Married Filing Jointly: \$78,750
- Single: \$50,600
- Head of Household: \$50,600

This change will relieve millions of Americans of AMT tax liability.

### **Estate and Gift Tax Rates**

ATRA permanently extends the \$5 million exclusion, indexed to inflation, and unified exemption amount with portability. The indexed amount for 2013 is \$5.25 million. The tax rate was raised from 35% to 40%. Since estate and gift tax rates were slated to return to a \$1 million exclusion amount and 55% top rate, this is welcome news for affluent taxpayers with large estates, and dis-incentivizes charitable giving.

# Limitations on Deductions: Pease

The Pease Limitation reduces the total amount of itemized deductions that are allowable by the lesser of a) 3% of amounts over \$250,000 (single taxpayers), \$275,000 (heads of household) and \$300,000 (married, filing jointly) or b) 80% of the taxpayers' itemized deductions. Forecast: the threat here sounds a lot worse than it will be.

### **Medicare Contribution Tax**

The Affordable Care Act calls for a Medicare contribution tax of 3.8% that will be imposed on capital gains, dividends, interest, and other unearned income in 2013 for taxpayers over \$200,000 (for single taxpayers and heads of households) or \$250,000 (for married filing jointly).

So that is an overview of some changes in tax law. Will they really affect charitable giving? That remains to be seen, because tzedakah comes not just from the brain, but from the heart as well.





Join us in exploring the diversity of the Israeli society. Today there are almost 8 million people living in Israel. According to the UN it is one of the most populated countries in the world. In this conversation we will explore diversity within the Jewish population of Israel and also get to know some of the fascinating minority groups. Talk about what brings them together and where some of the challenges rise.



(2012) Set in provincial sunny Tiberias, the plot consists of a collection of wonderfully strange vignettes that grow in richness and complexity as the film progresses. Israeli metropolis commemorated in special edition of Swedish vodka brand.

After New York (or to be more exact – Brooklyn), Vancouver, Istanbul and a series of other fascinating cities around the world, Tel Aviv is becoming part of the desired list of cities who have got their own special Absolut Vodka bottle.

The Absolut Tel Aviv bottle is being released as part of the Absolut Blank series designed by artist Nir Peled, who uses the professional name Pilpeled. He joins a long and distinguished list of artists from all over the world who have designed posters and other items for the Swedish vodka brand, including Andy Warhol, Jean-Michel Basquiat, Keith Haring and others.

The bottle, which is being released in a limited edition of 150,000 units, commemorates Tel Aviv's ficus tree boulevards. It also serves as a tribute to the club and nightlife culture in the city. "To understand Tel Aviv, one must walk its streets," Pilpeled says of the bottle he created, as part of an initiative of the Tempo beverage company's alcohol division and in cooperation with the Allenby Concept House owned by Srulik Einhorn and Guy Assif. # Recipe of the Month

# ARUGULA, WATERMELON AND FETA SALAD

1/4 cup freshly squeezed orange juice 1/4 cup freshly squeezed lemon juice (2 lemons)

1/4 cup minced shallots (1 large)

1 tablespoon honey

1/2 cup good olive oil

1 teaspoon kosher salt

1/2 teaspoon freshly ground black pepper 6 cups baby arugula, washed and spun dry

1/8th seedless watermelon, rind removed, and cut in 1-inch cubes

12 ounces good feta cheese, 1/2-inch diced 1 cup (4 ounces) whole fresh mint leaves,

cup (4 ounces) whole fresh mint lea julienned

Whisk together the orange juice, lemon juice, shallots, honey, salt, and pepper. Slowly pour in the olive oil, whisking constantly, to form an emulsion. If not using within an hour, store the vinaigrette covered in the refrigerator. Place the arugula, watermelon, feta, and mint in a large bowl. Drizzle with enough vinaigrette to coat the greens lightly and toss well. Taste for seasonings and serve immediately.







# Stress management: have you taken time for yourself lately?

**Jewish** recently sponsored a Continuing Education Unit (CEU) entitled "You're Not Being Chased by a Bear: Educating our Clients on Effective Stress Management." This CEU, meant for educating professionals in the mental health field, was conducted by Stacy Simera, who is a licensed social worker/counselor. Stacy discussed ways that social workers/counselors, and others involved in the mental health field, can better assist clients and their families in managing stress in their lives, in order to ensure a better quality of life for themselves and their family members. During the CEU, I realized that I am not doing enough to minimize my own stress level, and that as a social worker, a mom, a wife, a daughter, and a friend that I need to practice and model stress reduction. Recently, I listened to statistics from a survey entitled "Stress in America" (apa.org), and I realized that I was far from being the only overly stressed American. The information that was shared in the CEU turned out to be valuable information for everyone, not just mental health professionals.

My name is Lydia Wolf and I am a Licensed Social Worker /Case Manager for Jewish Family Service. I wear many different "hats" in my life, and my role changes frequently

Service throughout the day. From 9am to 2pm on Mondays and Tuesdays I am a Licensed Social Worker for JFS. After 2, I revert back to being a mom to two teenaged daughters, a daughter to my parents, a dog owner, etc. I go grocery shopping, clean the house, do laundry, and the list is endless. Sound familiar? I know that I am not alone -- we all lead busy, hectic lives, and we all "wear many different hats." Did you notice that I did not include any activities or time in my day for my own stress reduction?

We live in an age of constant information bombardment from 24 hour news sources that is full of bad news, worries about our finances, our relationships, our jobs, the economy, our health, our kids, our parents. Once again, the list seems endless. Though we can't control everything that the outside world "throws" our way, we can attempt to change the way we handle it. When we are overly stressed, and we do nothing to mitigate it, we suffer, and those around us suffer.

Long-term effects of staying in stress mode too long can include; muscle tension, depression, vision problems, high blood pressure, obesity, sleep disturbances, heart disease, memory problems, and skin conditions. I can say with certainty that I have experienced some of these symptoms when I know my stress level is too high, and I can see these effects in my clients and my family members when they are under stress. I can also see the effect that my increased stress level may have on my clients, my children and my husband.

What can we do to mitigate our stress level? There are numerous options for relaxation, and some can be practiced in as little as 10 minutes a day. Yoga which can be done at home or in a class setting is a great way to relieve the stress. Other ways are abdominal breathing, guided imagery, massage, tai'chi, progressive muscle relaxation, music/sound, meditation, and reading a book. Notice I did not mention watching television, which is not a true form of relaxation. Relaxation is making a conscious choice to focus on you, neglecting the outside world for a few minutes or hours every day. The positive effects of purposeful stress reduction on our bodies and those around us are unmistakable. How many of us can say that we do that on a regular basis? I, for one, plan to start. Again. # Lippman trip to Israel provides students new experiences, perspectives

There is a famous song in Hebrew that translates to: "Jerusalem, city of gold." Near the end of our 7th and 8th grade trip, we woke up and looked out the window of the hostel we were staying in to view the old city of Jerusalem, with its gold tinted stone, a holy site for Jews, Christians and Muslims. We felt inspired as we walked in the shadow and footsteps of many kings, rulers, and spiritual leaders whose memory and legacy are precious to so many that follow their positive examples and teachings here and around the world.

So many of our experiences during this trip reminded us of the importance of taking care of our fellow human beings. We began one morning

at a soup kitchen in Israel, where our students lived the value of tzedakah (which literally translates to "justice"). This value is not simply a "good deed" as it is often mistranslated; rather, it is making the world a more just place because that is what we are expected to do. On this day, our students practiced this value by literally giving back with service. We spent over an hour cutting cucumbers, peeling potatoes and dicing squash for salads and soup that fed approximately 100 people who are either homeless, Holocaust victims in their 80s and 90s, or people identified by local rabbis as needy members of this community. The leader of the soup kitchen, who works with many older groups, was amazed by our group's tenacity and productivity-



so much so, that he had to call in for additional produce for us to chop as we greatly exceeded his typical expectations.

After this experience, we went to the most famous "shuk" (market) in Jerusalem to observe many getting ready for Shabbat. Students were also able to do some shopping, but we gave them a special mission. They were asked to take five shekels and buy something small for someone else on our trip as a way to show our entire traveling community that we appreciate one another. It was heart-warming to observe our students take on this responsibility with a sense that we are all on this positive journey together and have all supported each other throughout.

I think of the three times (this time included) that I have been fortunate enough to accompany Sarah Greenblatt and a group of Lippman students to this land. Some of the students I went with 15 years ago have shared with me how this trip forever changed the way in which they see the



dents. This will provide a greater impact for the rising grade 8 students, who will continue their educational journey with us next year and thus build upon their learning from this experience. It also allows the 7th/8th grade students the opportunity to live and learn with our Northern Cheyenne Nation partners, on the reservation in Montana during the alternate year when not going to Israel. Additionally, this trip included two members of the Northern Chevenne Nation. Not only did they learn with us,



they pointed out similarities and learning opportunities through their observations and questions. In particular, the use of song, sacred ritual and the oral tradition common to both Jews and Northern Cheyenne offered very interesting points of learning and sharing.

Finally, this trip has reaffirmed what I know about high-quality immersive experiential learning for middle school students. Trips like this bring out the best in our kids. They push themselves in positive ways as they engage in experiences that take them out of their comfort zone and require self-reflection. These experiences also push our students to care for one another in ways only a trip like

this can offer. If a child missed home (which happened for only brief moments on this trip) the first to offer comfort, even before a teacher, were fellow students. Friendships form and deepen through these experiences and again will allow our students to understand even the concept of friendship in much more profound ways.

I did not have this experience as a child and am thankful that our school, staff, board, and community have continued to support such an important trip for these students. They will carry these positive lessons into the communities in which they find themselves as adults in the not-too-distant future.

Echoes and Reflections: Multimedia Curriculum is the result of an unprecedented partnership among three leaders in Holocaust education: Anti-Defamation League, the USC [University of Southern California] Shoah Foundation Institute for Visual History and Education and Yad Vashem.

The workshop features presentations by Dr. Helene Sinnreich, Executive Director Center for Judaic and Holocaust Studies, Youngstown State University and a local Holocaust survivor. Participants will each receive a free copy of Echoes and Reflections, with access to lesson plans, primary sources, handouts, pictures, video

testimonies and more. CEU credits will be available. The Workshop is presented in partnership with The Center of Holocaust and Humanity Education.

For nearly 30 years, the Ohio Council on Holocaust Education has provided Holocaust education and resources for teachers throughout the state of Ohio. Recent appointments to the council include: Mark Ebner, from Columbus; Barbara White, General Manager Branch Libraries, Akron Summit County Public Library; and Esther Cohen Hexter, Holocaust Educator and lecturer from Akron.

A co-founder of Children of Holocaust Survivors Group Columbus Chapter, Ebner oversaw a project to record 33 local survivors' testimonies in participation with Yale University. He traveled to Poland numerous times for research to produce the film Survivors Journey, and constructed a building to house Columbus Holocaust survivors' video library and exhibit.

White, a renowned expert in Holocaust resources, has co-chaired Holocaust Teacher Seminar for the Jewish Community Board of Akron for 17 years. She has served on the City of Akron Holocaust Commemoration Committee and as a judge for its Arts and Writing Contest for decades.

Hexter ran the Educational and Holocaust Resource Center for the Jewish Community Board of Akron for 25 years. She served as chairperson and long-time member of the City of Akron Holocaust Commemoration Committee and chaired the writing portion of its Arts and Writing Contest, where she still serves as a judge.
