## The Texas Social Studies Textbook Adoption: Positive Outcomes for Jews, Judaism, and Israel

### What we have done

In 2009, the Public Education Initiative (PEI) began its mission of promoting high quality, accurate education for Texas students. By building positive, professional relationships with members of the State Board of Education (SBOE), Texas Education Agency (TEA) professionals, and educators throughout the state, PEI was successful in securing over two-dozen changes and corrections to the Texas Essential Knowledge and Skills (TEKS) standards specific to Jews, Judaism, and Israel.

Some of these changes were integral to an accurate narrative regarding the creation of and ongoing challenges faced by the State of Israel. Others addressed the Holocaust and Jewish contributions to Western Civilization. All were essential to providing Texas students and teachers with high quality, accurate, and balanced educational resources. During this time frame, PEI also worked with the SBOE on other issues, including developing a more transparent process of textbook review and supporting Jewish community member nominations to the State Textbook Review Panels.

### What's next?

At their September meetings, the SBOE will hear public testimony regarding publishers' print and digital submissions for adoption. The media focus will likely center on the political aspects of the adoption process; however, it is important that our readership knows that PEI's work on behalf of the Jewish community has been largely positive and well-received. Based on PEI's and the Institute for Curriculum Services' (ICS) ongoing work, multiple corrections to the textbooks have already been secured; however, there is still work to be done.

PEI testified at the September 16, 2014, SBOE meeting in support of the 14 textbook reviews completed by ICS (SPRING 2014 newsletter). These reviews were submitted by PEI, the Jewish Community Relations Council of the Jewish Federation of Greater Dallas, the Jewish Federation of Greater Dallas, and the Jewish Federation of Fort Worth and Tarrant County. The reviews focus on quality, accuracy, and balance regarding Jews, Judaism, and Israel. We asked the SBOE to require that publishers work with ICS to make the remainder of our submitted corrections in order to be placed on the state's approved list for adoption and ultimate use in Texas classrooms.

### What you can do to help

Please write the SBOE in support of PEI's work and the ICS reviews. If you are a member of PEI's statewide parent network, you should have received an email with letter writing tips.



## 2014-15 CALENDAR OF JEWISH HOLY DAYS

- This calendar has been prepared to assist schools in scheduling events such as major assignments, examinations, assemblies, field trips and graduation as well as school-related programs for parents.
- The Jewish Sabbath begins at sundown on Fridays and concludes at dark on Saturdays.
- To avoid penalizing students or workers for their religious observance, schools are asked to be sensitive to the scheduling of events on Jewish holidays and the Jewish Sabbath.
- As with any religion, levels of observance vary among individuals. We respectfully request that schools make reasonable accommodations for members of the Jewish community who wish to observe these holidays.

Purim	Mar. 5
Passover* (First 2 days)	Apr. 4-5
Passover (Intermed. days)	Apr. 6-9
Passover* (Last two days)	Apr. 10-11
Yom HaShoah	Apr. 16
Yom HaAtzmaut	Apr. 23
Shavuot*	May 24-25

All Jewish holidays begin at sundown on the previous day and conclude at sundown on the last day.

Holidays marked with an asterisk\* denote the Jewish High Holy Days and major Biblical festivals in observance of which labor, including secular studies, is traditionally prohibited. As a result, many Jewish individuals are absent from both school and work.
